The Art of Recycle (kids ages 9-11 years)

Tuesdays starting June 20th to July 25th (6 sessions / 10 am-12 pm)

The United States has the highest amount of waste generated per person of any country at an average of 4.6 pounds per day. Only around 1/10 of solid garbage in the United States is recycled each year! While these facts are dire, let's teach kids how to be part of the solution and make fun recycled art!

The Art of Recycle is a FREE Summer Workshop for kids ages 9-11 who express a need for a structured activity, and would be available on a consistent basis. This 6-week program will meet once a week and is based on the concept of recycled art. Recycled art is an unusual but very creative art form that uses existing materials and recycles them to create works of art. In our sessions, kids will work with Barnstone Art for Kids staff, volunteer mentors and their peers as they approach their art projects and experience the healthy, calming benefits of creating art all while saving our planet!

The ACE scale quantifies adversity in three categories: abuse, neglect and household dysfunction. We recognize that adversity of this kind is frequently passed down generation to generation and acknowledge your courage in requesting help.

Your personal information will be kept confidential and will not be released to anyone outside the organization for any reason.

_____ I will contact Barnstone Art for Kids if my child will be absent on any assigned program day. We will determine your child to be withdrawn from the Barnstone Art for Kids program if he/she misses three consecutive instructional days without prior acknowledgement or notification.

_____ Barnstone Art for Kids collects information to satisfy requests for program effectiveness and documentation required by funders for continued financial support. Your personal information will be kept confidential and will not be released to any grant, foundation or donor for any reason.

_____ I understand that Barnstone Art for Kids may terminate my child's participation if he/she fails to comply with behavioral requirements particularly regarding safety of self, mentors, peers, facility, equipment and supplies.

_____ I give Barnstone Art for Kids permission to communicate with me by telephone, text, email or other means. I understand Barnstone Art for Kids privacy policy applies to the information I provide.

_____ I/we understand the late arrival or early pick up affects the dynamics of the entire group and will make every possible effort to arrive and pick up on time.

_____ I/we understand my child will be released only to myself or authorized individuals. I will provide authorized individuals names if I am unable to pick up my child.

Many children experience stressful life events that can affect their health and wellbeing. The results from this questionnaire will assist your child's doctor in assessing their health and determining guidance. Please read the statements below. Count the number of statements that apply to your child and write the total number on the line provided.

Please DO NOT mark or indicate which specific statements apply to your child.

1) Of the statements in Section 1, HOW MANY apply to your child? Write the total number in the box.

Section 1. *At any point since your child was born...*

- Your child's parents or guardians were separated or divorced
- Your child lived with a household member who served time in jail or prison
- Your child lived with a household member who was depressed, mentally ill or attempted suicide
- Your child saw or heard household members hurt or threaten to hurt each other
- A household member swore at, insulted, humiliated, or put down your child in a way that scared your child OR a household member acted in a way that made your child afraid that s/he might be physically hurt
- Someone touched your child's private parts or asked your child to touch their private parts in a sexual way
- More than once, your child went without food, clothing, a place to live, or had no one to protect her/him
- Someone pushed, grabbed, slapped or threw something at your child OR your child was hit so hard that your child was injured or had marks
- Your child lived with someone who had a problem with drinking or using drugs
- Your child often felt unsupported, unloved and/or unprotected

2) Of the statements in Section 2, HOW MANY apply to your child? Write the total number in the box.

Section 2. *At any point since your child was born...*

- Your child experienced harassment or bullying at school
- Your child lived with a parent or guardian who died
- Your child was separated from her/his primary caregiver through deportation or immigration
- Your child had a serious medical procedure or life threatening illness
- Your child often saw or heard violence in the neighborhood or in her/his school neighborhood
- Your child was often treated badly because of race, sexual orientation, place of birth, disability or religion
